<b>Remote Patient Monitoring Reimbursement</b>	
<p><b>Office of Adult Service and Aging</b> In-home services, which is defined as including “telehealth services”, may be provided to an individual who demonstrates a need for long-term supports and services through an assessment and the following criteria:</p> <ul style="list-style-type: none"> <li>• The individual is residing at home;</li> <li>• The individual is age 60 or older or is age 18 or older with a disability; and</li> <li>• The individual is not eligible for other programs which provide the same type of service.</li> </ul> <p><i>Source: SD Regulation 67:40:19:04.</i></p>	Please see “Comments” section below.

**COMMENTS:** South Dakota's Department of Health and Human Services, Adult Services and Aging offers reimbursement for a home based monitoring system that monitors an individual's clinical data daily; such as heart rate, blood pressure, oxygen saturation, temperature, weight and can be a medication reminder depending on the unit available.

Telehealth includes equipment rental and the set up and availability of a nurse's time to monitor and provide feedback to the individual, their family, and/or consultation with the individual's physician and the Adult Services and Aging Specialist.
